The following has been agreed:

### A. Purpose of the Agreement and General Conditions

Under this agreement Hannan Carmeli, herein after referred to as "the Expert", will assist EMERGE. The services will be rendered as external service, framed of Protoatlantic Interreg Atlantic Area Project (EAPA 303/2016) funded by the European Commission.

The agreement will terminate without further notice upon completion of the services. The services are completed satisfactorily when Emerge has approved the services.

### B. Services

The services to be carried out relate to the following:

*Duration of the agreement:*

This agreement enters into force on the date of the last signature of it and shall last for the duration of the acceleration program of Protoatlantic.

*Position:*

Expert in charge of workshop 'Partnership Agreement and Team structure. Leadership' which will take place on 29<sup>th</sup> November.

### C. Remuneration

The remuneration will consist of fees.

Travel and accommodation of the stay of the expert is also included.

**Your tasks include:**

- Prepare the material necessary to give the master class: a theoretical class from 9-13:30h and practical session from 15-18h. This material will be sent to EMERGE prior to the workshop.
- The authorization in order to be recorded the master class. Only participants with credentials will be able to have access to it.
- Sharing your professional profile and photo to be published in the Protoatlantic website.
- Answer any question or email of a startup which participates in your workshop for 2 weeks after the workshop.

The remuneration will be directly related to the number of hours given in the workshop (7h) and the estimated hours for solving questions (2 h). Therefore, the price per workshop is 600 EUR (66.7 EUR/hour)

The TOTAL amount to be invoiced is: «600» EUR (incl. VAT and taxes).

No further compensation will be provided.

Payment will be made upon completion of the services, after approval by EMERGE of the corresponding work. The Expert shall present an invoice to EMERGE bearing reference to the present agreement.

**D. Satisfactory execution and Quality control**

The Expert will complete the tasks satisfactorily and ensure a high quality of the expected inputs.

**E. Insurance**

Insurance covering against accidents and acute medical treatment costs is to be undertaken by the Expert.

**F. Termination**

The agreement will terminate without further notice upon completion of the services.

**G. Confidentiality**

The Expert undertakes to respect the confidentiality of any information which is linked, directly or indirectly, given during the workshop, and not to divulge to third parties, nor use for his/her own benefit or that of any third party, any document or information not available publicly; and that he/she shall continue to be bound by this undertaking for 5 years after the contract has ended. The Expert accepts that he/she will be personally responsible for maintaining the confidentiality of any documents or electronic files sent to him/her.

## H. Disagreement

Any question of understanding or fulfilment of the agreed conditions for the engagement as well as any question arising between the Expert and EMERGE which result from or are connected with the present agreement must be settled amicably.
